TERMS AND CONDITIONS.

1. The tenders should be addressed to the Director General , Kerala Institute of Local Administration, Mulamkunnathukavu, Thrissur, Pin-680581 in a sealed cover with the tender number and name as “ TENDER FOR SUPPLY OF COMPUTER CONSUMABLE FOR A PERIOD OF ONE YEAR” duly super scribed on the cover.

2. The tenders should be in the prescribed form which can be obtained from the officer mentioned below on payment of the price which is also noted below. Duplicate copies of tender forms will also be issued at the rate specified below. The cost of tender forms once paid will not be refunded.

Tenders which are not in the prescribed form are liable to be rejected. The rates quoted should be only in Indian currency. Tenders in any other currency are liable to rejection.

3. Intending tenderers should send their tender so as to reach the officer mentioned below, on due date and time (noted below). No tender received after the specified date and time will be accepted on any account. The rates will be considered firm for acceptance till the tenders are processed. Tenders with price variation clause and/or 'subject to prior sale' conditions are liable to be rejected.

4. (a) Every tenderer who has not registered his name with the State Government (Stores Purchase Department) should send along with his tender, an earnest money of Rs.10000/-. The amount may be paid by demand drafts (crossed) drawn in favour of Director Generala , KILA, Thrissur payable at Thrissur. Cheques will not be accepted. The earnest money of the unsuccessful tenderers will be returned as soon as possible after the tenders are settled; but that of the successful tenderers will be adjusted towards the security that will have to be deposited for the satisfactory fulfillment of the contract. No interest will be paid for the earnest money deposited.

(b) Tenderers whose names are registered with Government (Store Purchase Department) are generally exempted from furnishing earnest money for such articles or which they have registered their names. If they tender for stores other than those for which they have registered their names they will have to furnish earnest money as in the case of unregistered firms. Registered firms will have to quote invariably in every tender they submit the registration number assigned to them by the Stores Purchase Department.

(c) (i) Small Scale Industries and Cottage Industries and Industrial Co-operative within the State which are certified as such by the Director of Industries and Commerce or by the Regional Joint Directors of Industries and Commerce will be exempted from furnishing earnest money deposits in support of tenders submitted by them to Government Departments. The Khadi and Village Industries Co-operative Societies and the institutions registered under the literary, Scientific and Charitable Societies Act and financed by the Kerala Khadi and Village Industries Board within the State which are certified as such by the Secretary, Kerala Khadi and Village IndustriesBoard will be exempted from furnishing earnest money deposits in support of tenders. Also, EMD exemption is allowed in accordance with the latest rules of the Kerala Store Purchase Manual.

(d) In the matter of purchase of stores Small Scale Industrial Units sponsored by the national Small Industries Corporation Ltd. New Delhi and in respect of which competency certificates are issued by the Corporation will be exempted from payment of earnest money deposits subject to the latest orders by the store purchase department.

(e) The exemption stipulated in clause (b) and (c) above will not, however, apply to tenders for the supply of raw Materials, or dietary articles or supply of stores on a rate or running contract basis.

5. The tenders will be opened on the appointed day and time in the office of the undersigned, in the presence of such of those tenderers or their nominees who may be present at that time.

6. If any tenderer withdraws from his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money, if any, deposited by him will be forfeited or such action taken against him as deemed fit. Tenderers shall invariably specify in their tenders the delivery conditions including the time required for the supply of articles tendered for.

(a) The tenderer shall clearly specify whether the articles offered bear Indian Standards Institution Certification Mark or not. In such cases, they shall produce copies of certification mark along with their tender in support of it.

(b) Tenderers shall clearly specify whether the goods are offered from indigenous sources, from imported stocks in India or from foreign sources to be imported under a license. KILA reserves the right to reject offers for import of goods if the import trade control policy in force at the time of award of the contract prohibits or restricts such imports.

7. Tenders should be submitted for all the items mentioned in the notice; partial tenders will not be accepted. The final acceptance of the tender rests entirely with KILA, who do not bind themselves to accept the lowest or any tender. However, the tenderers must be prepared to carry out any portion of the supplies included in their tenders that may be allotted to them.

8. In the case of materials of technical nature the successful tenderer should be prepared to guarantee satisfactory performance for a definite period under a definite penalty.

9. Communication of acceptance of the tender normally constitutes a concluded contract. Nevertheless, the successful tenderer shall also execute an agreement for the due fulfillment of the contract within the period to be specified in the letter of acceptance.

10. The contractor shall have to pay all stamp duty, lawyer's charges and other expenses incidental to the execution of the agreement. Failure to execute the agreement within the period specified will entail the penalties set out in para 12 below.

(a) The successful tenderer shall, before signing the agreement and within the period specified in the letter of acceptance of his tender, deposit a sum 50000/- as security for the satisfactory fulfillment of the contract. Letters of guarantee in the prescribed form for the amount of security from an approved Bank will also be considered enough at the discretion of KILA. If the successful tenderer fails to deposit the security and execute the agreement as stated above, the earnest money deposited by him

will be forfeited to KILA, and the contract arranged elsewhere at the defaulter's risk and any loss incurred by KILA on account of the purchase will be recovered from the defaulter who will, however, not be entitled to any gain accruing thereby. If the defaulting firm is a registered firm their registration is liable to be canceled.

(b) In case where a successful tenderer, after having made partial supplies fails to fulfill the contracts in full, all or any of the materials not supplied may at the discretion of the Purchasing Officer, be purchased by means of another tender/quotation or by negotiation or from the next higher tenderer who had offered to supply already and the loss, if any, caused to the KILA shall thereby together with such sums as may be fixed by the Director General, KILA towards damages be recovered from the defaulting tenderer.

(c) Even in cases where no alternate purchase are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate shown in the tender of the defaulter shall be forfeited and balance alone shall be refunded.

11. The security deposit shall subject to the conditions specified herein, be returned to the contractor within three months after the expiration of the contract, but in the event of any dispute arising between the KILA and the contractor the Director General, shall be entitled to deduct out of the deposits or the balance thereof, until such dispute is determined, the amount of such damages, costs, charges and expenses as may be claimed. The same may also be deducted from any other sum which may be due at any time from KILA to the contractor. In all cases where there are guarantee/warranty for the goods supplied the security deposit will be released only after the expiry of the guarantee/warranty period and subject to the special condition No.10.

12. All payments to the contractors will be made by the Director General in due course by cheques, drafts/online transfer through Bank or District Treasury, Thrissur.

13. The tenderers shall quote also the percentage of rebate (discount) offered by them in case the payment is made promptly within fifteen days/within one month of taking delivery of stores.

14. The Contractor shall not assign or make over the contract or the benefits or burdens thereof to any other person or body corporate. The contractor shall not underlet or sublet to any person or persons or body to corporate the execution of the contract or any part thereof without the consent in writing of the Purchasing Officer who shall have absolute power to refuse such consent or to rescind such consent (if given) at any time if he is not satisfied with the manner in which the contract is being executed and no allowance or compensation shall be made to the contractor or the sub-contractor upon such rescission. Provided always that if such consent be given at any time, the contractor shall not be relieved from any obligation, duty or responsibility under this contract.

15. (a) IN case the contractor becomes insolvent, or goes into liquidation, or makes or proposes to make any assignment for the benefit of his creditors or proposes any composition with his creditors, for the settlement of his debts, carries on his business or the contract under inspection on behalf of his creditors, or in case any receiving order or orders for the administration of his estate are made against him or in case in which under any clause or clauses of this contract the contractor shall have rendered himself liable to damages amounting to the whole of his security deposits, the contract shall, thereupon after

notice given by the Director to the Contractor be determined and the Director General, KILA may complete the contract in such time and manner and by such persons as the Director shall think fit. But such determination of the contract shall be without any prejudice to any right or remedy of the KILA against the contractor or his sureties in respect of any breach of contract therefore committed by the contractor. All expenses and damages caused to by any breach of contract by the contractor shall be paid by the contractor to KILA and may be recovered from him under the provisions of the Revenue Recovery Act in force in the State.

16. (a) In case the contractor fails to supply and deliver any of the said articles and things, within the time provided for delivery of the same, or in case the contractor commits any breach of any of the covenants stipulations and agreements herein contained, and in his part to be observed and performed, then and in any such case, it shall be lawful for Director General (if they shall think fit to do so) to arrange for the purchase of the said articles and things from elsewhere or on behalf of the KILA by an order in writing under the hand of the Purchasing Officer put an end to this contract and in case the KILA shall have incurred, sustained or been put to any costs, damages or expenses by reason of such purchase or by reason of this contract having been so put and end to or in case any difference in price, compensation, loss, costs, damages, expenses or other moneys shall then or any time during the continuance of this contract be payable by the contractor to the KILA under and by virtue of this contract, it shall be lawful for the KILA from and out of any moneys for the time being payable or owing to the contractor from the KILA under or by virtue of this contract or otherwise, to pay and reimburse to the KILA all such costs, damages and expenses they may have sustained, incurred or been put to by reason of the purchase made elsewhere or by reason of this contract having been so put an end to as aforesaid and also all such difference in price, compensation, loss costs, damages, expenses and other money's as shall for the time being the payable by the contractor aforesaid.

(b) In case any difference or dispute arises in connection with the contract, all legal proceedings relating to the matter shall be instituted in the Court within whose jurisdiction the Director General, KILA voluntarily resides.

17. Any sum of money due and payable to the contractor (including security deposit returnable to him) under this contract may be appropriated by the purchasing officer or any other person authorised by KILA and set off against any claim of the Purchasing Officer, KILA for the payment of a sum of money arising out of or under any other contract made by the contractor with KILA or any other person authorised by Director General, KILA. Any sum of money due and payable to the successful tenderer or contractor from KILA shall be adjusted against any sum of money due to KILA from him under any other contracts.

18. Every notice hereby required or authorised to be given may be either given to the contractor personally or left at his residence or last known place of abode or business, or may be handed over to his agent personally, or may be addressed to the contractor by post at his usual or last known place of abode or business and if so addressed and posted shall be deemed to have been served on the contractor on the date on which, in the ordinary course of post, a letter so addressed and posted would reach his place of abode or business.

19. The tenderer shall undertake to supply materials according to the standard sample and/or specifications.

20. No representation for enhancement of rates once accepted will be considered.

21. Any attempt on the part of the tenderers or their agents to influence the Director General, KILA in their favour by personal canvassing with the Officers concerned will disqualify the tenderers.

22. Tenderers should be prepared to accept orders subject to the penalty clause for forfeiture of security in the event of default in supplies or failure to supply within the stipulated period.

23. Telegraphic quotations will not be considered unless they give details of prices and are immediately followed by confirmation with full relevant details posted before the due date of the tender.

24. The prices quoted should be inclusive of all duties, cesses, etc., except GST, GST will be quoted separately which are or may become payable by the contractor under existing or future law or rules of the country of origin supply or delivery during the course of execution of the contract.

25. The tenderer should submit their GST Registration certificate and Their Registration /certificate incorporation ect...

26. Special conditions, if any, of the tenderers attached with the tender will not be applicable to the contract with the tender unless they are expressly accepted in writing by the purchaser.

27. The tenderer should send along with his tender an agreement executed and signed in Kerala stamp paper of value Rs.200 purchased in the Kerala State. A specimen form of agreement is given as annexure to this tender. Tenders without the agreement in stamped paper will be rejected outright. But in deserving cases where agreement has not been received, the Purchasing Officer may exercise his discretion and call upon such tenderer to execute the agreement within a period of ten days from the date of issue of such intimation, if the Purchasing Officer is satisfied that the omission to forward the agreement along with the tender was due to causes beyond the control of the tenderer and was not due to any negligence on his part. Agreement received from a tenderer after the above time limit will not be considered.

Special Terms and Conditions

1 Supply of the computer consumables in good condition as per our work order is the sole responsibility of vendors concerned.

2. Items received in damaged condition is rejected after detailed verification and testing by the authorities

3. Vendors should have sufficient Stock of the items and office facility, preferably in Thrissur or Palakkad. An agreement should be signed with service conditions during the warranty period.

4. Delivery period for the entire purchase order will be two weeks from the date of purchase order.

5. Failure to supply and install items within the specified time as per the agreement, a penalty of one percent of the item per week will be levied. (The time will be extended only the prior concurrence from KILA).

6. Price quoted should be valid until tenders are processed. The tenders submitted without fulfilling the conditions as stated will be summarily rejected.

7. The rate quoted should be for delivery and installation of items at KILA, Mulamkunnathukavu. The items should be delivered within two weeks from the date of receipt of the purchase order.

8. The Successful Tenderer shall also provide the name and mobile number of a key person, who can be contacted at any time, even beyond the office hours on holidays. The person should be capable of making arrangement for supply of the desired items even on short notice to KILA HQ.

9. The Director General, KILA shall be the final authority to reject full or any part of the supply which is not conforming to the specification and other terms and conditions.

10. The successful firm will be required to enter a rate contract with KILA to supply the Computer consumables for a period of one year from the date of award of the contract. KILA shall, however, reserve the right to terminate the contract at any time without assigning any reason.

11. No escalation in rates on any account will be permitted during the contract period.

12. The bidder, once applied, will not be allowed to withdraw after tender opening.

13. Security Deposit : The Successful bidder shall require to submit the performance security after receipt of award of contract in the form of Bank Guarantee (BG) / or Fixed Deposit Receipt (FDR) from any Nationalized Bank duly pledged in the name of "Director General Kerala Institute of Local Administration" within 10 days from the award of contract for an amount of **Rs. 50,000/-** (Rupees Fifty Thousand Only).

14. The security deposit can be forfeited by order of this Institute in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non-observance of any condition of the contract. In case, the successful bidder shows inability at any stage, after the contract is finalized and awarded for whatsoever reason(s), to honor the contract, the EMD/Performance Security deposited would be forfeited. Performance Security will be discharged after completion of contractor's performance obligations under the contract.

15. Specification: The Contractor must confirm in writing that the goods supplied by them shall be as per specification of goods mentioned in Annexure – "I" and in case of any variation, the contract shall be liable to be cancelled immediately. The Security cum Performance Guarantee will also be forfeited.

16. BID PRICES:

It should be submitted in form given in Annexure II. The price quoted will be exclusive of GST and inclusive of all applicable charges (i.e. packing, forwarding, postage and transportation), at KILA Mulamkunnathkavu and shall be fixed and final. Taxes, as applicable will be extra, which will separately quoted in the bid, At the time of payment Income Tax or any other Tax payable shall be deducted at source.

The rate quoted by the bidder shall remain fixed during the entire period of rate contract and shall not be subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.

17. The tender should be valid for a period of 90 days from the date of opening of the tender.
