envelope(s) on the e-GP website. Bids shall be accepted only through online mode on the e-GP website and no manual
submission of the same shall be entertained. Late received bids will not be accepted any manner. A bid submission fee shall be remitted online
during the time of bid submission. The hard copies of certificates and documents, such as copy of remittance towards.
Bid security ,Duly filled and signed copy of preliminary agreement, Copy of confirmation of bid submission in the e-tender
portal,shall be submitted subsequently after online submission of bids in a separate cover by registered post/
portal, Duly filled and signed declaration shall be submitted subsequently after online submission of bids in a separate cover by
registered post/speed post before the date and time of opening of technical bid. Price Bid shall only be submitted through online.security

Details regarding remittance of bid submission Fee and Bid ,Bid preparation and submission are mentioned in the bid document.

The bids shall be opened online on at the office of the undersigned at the prescribed time and date in the presence of the Bidders / their authorized representatives who wish to attend at the above address. If the e-tender opening date happens to be on a holiday or non-working day due to any other valid reason, the e-tender opening process will be done on the next working day at same time and place. Online bids are to be accompanied with a preliminary agreement executed in Kerala stamp paper worth Rs.200/-.

Bids received online without the details mentioned in e-tender cover details will not be considered and shall be summarily rejected.

Since the major component of this bids contains of civil works, the civil contracors will have to submit the undertaking and obtain the valid PWD Electrical license. In this connection a MOU (Memorandom of Understanding) in this respect entered with the PWD Electrical contractor and the selected civil contractor should be furnished at the time of executing agreement.
